Cathy Walker - Former National Health, Safety and Environment Director, CAW, will be speaking about the importance of worker participation in health and safety, the "union health and safety effect", where studies show that unionized workplaces are safer and will provide an international perspective and lessons learned from her health and safety work in Australia, China, South Africa and India.

David Bennett - Former National Health, Safety and Environment Director, CLC will provide a historical perspective on health and safety regulations, the right to know about toxic chemicals and will link using environmental successes as a model to deal with health and safety problems.
