Raids and other threats to Licensed/Registered Practical Nurses and CUPE fight backs

CUPE's Licensed Practical Nurses (LPNs) and Registered Practical Nurses (RPNs) are experiencing increased resistance to the development of their profession. Registered Nurse unions in some provinces are raiding CUPE, and in many places they are aggressively challenging the increased utilization of LPNs/RPNs. This session is a chance for delegates to hear about key campaigns and discuss issues of concern to LPNs/RPNs.

From this session, we aim to:

- Hear from Hospital Employees' Union/CUPE LPNs about the BC Nurses' Union raid;
- Share information about the ways in which CUPE RPNs/LPNs are under threat in other provinces;
