### National Convention and National Events Assistance Fund

**APPLICATIONS MUST BE FORWARDED NO LATER THAN DECEMBER 15, 2008.**

At the October 2007 National Convention, delegates approved an amendment to Article 14.1 (v) of the National Constitution as follows:

*"Commencing with the month of January 1992, 1/10 of 1% of any General Fund revenues received from per capita tax shall be placed in the National Convention and National Events Assistance Fund. The National Convention and National Events Assistance Fund shall be governed by regulations established by the National Executive Board."*

Our Bargaining Women's Equality Conference is a national event eligible for qualifying locals to apply for financial assistance.

The eligibility criteria for National Events Assistance is as follows:

- 1) Local Union financial capacity;
- 2) ensuring regional representation;
- 3) for specialized events, ensuring sector or sub-jurisdictional representation, or pension plan representation, or other designated representation as required;
- 4) ensuring gender balance, diversity representation, or participation of youth.

*The National Officers will have final authority to grant National Events Assistance to Local Unions.*

In order to apply for financial assistance under the National Convention and National Events Assistance Fund, the attached "Application Form – National Events Assistance Fund" must be returned along with the information included in the regular registration form.


Please note that the National Convention and National Events Assistance Fund is not unlimited, and that assistance is not guaranteed. The fund is intended to assist locals who could not otherwise attend a national conference, and to ensure regional and sector representation, gender, diversity and young worker representation, as well as other criteria that may be specific to the event held.

All applications will be considered, and all applicants will receive a reply.
