

CHILD CARE ARRANGEMENTS

ON-SITE

Arrangements are being made to provide child care at the Toronto Convention Centre during the 2017 national convention proceedings. The child care centre will be open Sunday, October 1st from 10:30 a.m. to 4:00 p.m., Monday, October 2 from 8:30 a.m. to 10:00 p.m., Tuesday, October 3 from 8:30 a.m. to 9:00 p.m., Wednesday, October 4 from 8:30 a.m. to 10:00 p.m., Thursday, October 5 from 8:30 a.m. to 6:00 p.m. and Friday, October 6 from 8:30 a.m. to 4:00 p.m.

CUPE will provide on-site child care at the 2017 national convention at no cost to the parent. However, a fee of \$50 per child is required to cover special trips and events.

If you wish to take advantage of the child care facilities to be provided at convention, please complete the attached "on-site" application form and send it to the national office **TO BE RECEIVED NO LATER THAN AUGUST 18, 2017.** **Your cheque for \$50 per child must be enclosed with your application.**

AT-HOME



Article 6.3(d) of the CUPE Constitution provides for a subsidy to offset at-home child care costs to a maximum of \$90 per day per delegate.

Following the convention, local unions may claim reimbursement on behalf of its delegate(s) by completing the attached "at-home" application, which must also be signed by the delegate and accompanied by a receipt for the expense incurred.

Applications for this subsidy must be sent to the National Secretary-Treasurer **TO BE RECEIVED NO LATER THAN JANUARY 9, 2018.**

CONVENTION YOUTH COUNCIL

In order to involve our youth and pave the way for up-and-coming leaders, CUPE provides a week-long education program for youth aged from 9 to 14 during the national convention. This program includes:

- Canadian labour history
- The importance of unionization
- Unions' roles in gaining equality for all
- Unions and the social justice movement
- CUPE's structure and governance

The Youth Council delegates will have guest status and will be able to visit the convention floor during the proceedings. They will then prepare a report which will be presented to convention delegates.

The cost of \$220 per child will cover lunches, snacks and cost of the program.

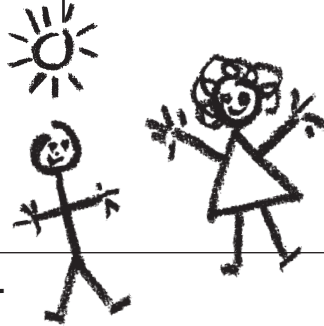
