Dear Mr. President:

On behalf of the Canadian Union of Public Employees (CUPE) we are writing today to express our concern for the safety of human rights defender, BERENICE CELEITA. From the evening of June 20th until the early hours of June 21st, a vehicle was parked outside Berenice Celeita's home in Bogotá. From her window she saw that the two occupants sitting at the front of the vehicle were taking photographs of her house and she saw a camera flash firing.

Berenice had just returned from a tour to Canada and the USA where she met with various organizations, institutions and government officials, including CUPE. We discussed with her the human rights situation in Colombia, including the situation in Buenaventura. We specifically discussed the importance of bringing to justice those with international economic interests which have benefitted from and have been responsible for human rights abuses and violations that have occurred during the course of Colombia's long-running internal armed conflict.

CUPE supports the work of NOMADESC and the communities and organizations with whom they work. We have travelled to Colombia on several occasions to meet with these individuals and communities in order to better understand the situation and seek ways to support their pursuit of justice.

It is extremely worrisome that while the peace talks continue, Colombians who are working for peace and human rights continue to be subjected to threats, harassment and intimidation.

We respectfully request that:

 Protection measures, in strict accordance with their wishes, be put in place to ensure the safety of Berenice Celeita, her family and other members of NOMADESC.
